**REGULAR BOARD MEETING MINUTES
NOVEMBER 13, 2023**

CALL REGULAR BOARD MEETING TO ORDER AND TAKE ATTENDANCE AND PLEDGE OF ALLEGIANCE: The Regular Board Meeting of November 13, 2023, was called to order at 6:00 p.m. by the President of the Board, Ms. Alexander, at the City of Windcrest's Council Chambers, 8601 Midcrown Drive, Windcrest, Texas, for the purpose of considering the following agenda. The Board's President determined that a quorum was present. Board members present were Ms. Alexander, Ms. Snead, Mr. Richards, Mr. Cockerham and Ms. Arnicar. Also, in attendance was David Wallace, General Manager, Ruben Barrera, Attorney and Leonard Young, Engineer.

B. THE BOARD WILL DELIBERATE AND MAY TAKE ACTION ON ARTHUR BRADY'S WATER UTILITY SERVICE BILLING ISSUE.

The Board President made a statement regarding Mr. Brady's bill: We understand Mr. Brady's position on the water bill. According to our District Policy the \$279.72 that Mr. Brady owes the District will remain on his bill until it's paid. When he makes payment for his current month's bill, he may also make a payment towards paying down that \$279.72 that he owes, or he may pay it all at one time if he wishes. The \$279.72 will remain on his bill until it is paid. If there is no payment on the past due amount any single month a \$5.00 late charge will be imposed on that amount. If no payment is made on, the past due amount, it will result in a \$5.00 charge each month.

C. The General Manager recommended that the Board leave this benefit at 75% The Board agreed.

The General Manager recommended that the District increase the "Service Availability" fee by \$2.85. This would go into effect in January 2024 or February 2024.

2. Water Usage Update: Our current pumpage for October 2023 was 26,555,000 gals, Total pumpage for the year is 865.02 acre/ft. The District's total Edwards permit is 1625.00 acre/ft. The Edwards Aquifer is currently around 635.50 ft. We are in STAGE III Restrictions. We are currently pumping 650,000 gal/per/day.

3. We are still replacing old water meters that no longer function. This will be a normal operational procedure. We are starting replacement of broken and old gate valves throughout the system. Still replacing bad curb-stops on meter change outs.

4. Working with the Engineers, on 2023-2024 Capital Improvement Projects.




