

RESOLUTION NO. 2023 - 50

OF THE BEXAR COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT #10 (“DISTRICT”) BOARD OF DIRECTORS (“BOARD”) APPROVING, AUTHORIZING AND ADOPTING AN INCREASE IN THE DISTRICT’S MINIMUM WATER RATES FOR RESIDENTIAL AND COMMERCIAL CUSTOMERS WITHIN THE DISTRICT EFFECTIVE ON FEBRUARY 23, 2024 TO SUPPORT THE DISTRICT’S APPROVED ANNUAL BUDGET AND REVENUE REQUIREMENTS (INCLUDING PROPOSED DEBT FOR NECESSARY CAPITAL IMPROVEMENTS) FOR FISCAL YEAR 2024; FINDING THE RESOLUTION TO HAVE BEEN CONSIDERED PURSUANT TO THE LAWS GOVERNING OPEN MEETINGS; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, pursuant to Section 51.338 of the Texas Water Code, the Bexar County Water Control and Improvement District #10’s (“District”) Board of Directors (“Board”) have the right to adopt water charges and fees; and

WHEREAS, the District’s rate schedule includes (a) residential water, sewer and irrigation water rates; and (b) commercial water, sewer and irrigation water rates for the District’s water and sewer customers based on water consumption and sewer use; and

WHEREAS, the District’s Board of Directors (“Board”) analyzed its current water rates and sewer rates to determine their adequacy; and

WHEREAS, the District’s Board now desires to approve, authorize and adopt an increase in the District’s minimum water rates for residential and commercial customers within the District effective on February 23, 2024 to support the District’s approved annual budget and revenue requirements (including proposed debt necessary capital improvements) for fiscal year 2024; now therefore:

BE IT RESOLVED BY THE DISTRICT’S BOARD OF DIRECTORS:

1. That an increase in the District’s minimum water rates for residential and commercial water customers within the District effective on February 23, 2024 to support the District’s approved annual budget and revenue requirements (including proposed debt for necessary capital improvements) for fiscal year 2024 as shown on the rate schedule attached to this Resolution as Exhibit “A” and incorporated herein for all purposes are hereby approved, authorized and adopted for implementation.


2. All minimum water rates for residential and commercial water customers within the District in effect prior to 12:01 a.m. on February 23, 2024 shall no longer be in effect as of 12:01 a.m. on February 23, 2024 and shall be superseded by the water rates shown on the rate schedule attached to this Resolution as Exhibit “A,” and as outlined in Sections 1 above.

3. It is officially found, determined and declared that the meeting at which this Resolution is adopted was open to the public, and that public notice of the time, place, and subject matter of the public business to be conducted at such meeting, including this Resolution, was given to all as required by the Texas Codes Annotated, as amended, Title 5, Chapter 551, Government Code.



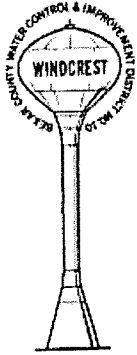
5. This Resolution becomes effective immediately upon its passage.
